- Must sign up to a GoRoam Ultra tariff with a handset over 24 or 36-months during the promotional period to receive a Christmas cracker and be eligible to win

Entry

To enter, customers must sign up to a GoRoam Ultra tariff with a handset over 24 or 36-months during the promotional period. Upon upgrade, customers will receive a Christmas cracker which will reveal whether they have won a prize.

You must have a valid account with MT in order to enter.
