# **Background and Priority**

- Isle of Man Residents
- Competition entry is only open to children aged between 3 -15 years.
- Entry must be completed at the Manx Telecom stand at the Royal Manx Agricultural Show on Friday 8th or Saturday 9th August 2025.
- Only one entry per child

### **Entry**

- Entrants must provide:

#### **Prizes**
